

# Eastern Nebraska Gun Club

## Mid-Range 600 Yard High Power Rifle League 2010

**DATES: April 11, July 11, September 12, October 10, 2010 Starting at 09:00 AM CST.**

**LOCATION:** Eastern Nebraska Gun Club at Louisville, Nebraska, is about 20 miles south of Omaha, Nebraska. Follow High Way 50 to Louisville turn off and go east on HY 66. Range is located 2.5 miles East of Louisville on Hwy 66. Range entrance is on North side of highway located at marker 12700, follow entrance road approx.1 mile north to the range. (ENGC GPS Coor 41.011767, -96.111750).

**COMPETITION OPEN TO:** Open to the public to anyone who can legally possess a firearm and to Juniors accompanied by an adult.

**RULES :** Current NRA High Power Mid-Range and F-Class Rules will apply.

**REGISTRATION FEES:** Individual / NRA fee: \$25.00 per competitor, juniors \$15.00 (plus a one time \$7 league fee).

**REGISTRATION AT THE RANGE.** Range will open at 7:30am. Registration and match packets will be at the trailer on the 600yd firing line from 7:30am to 8:30am. Squadding will end at 8:30am. There will be no food or sodas provided. Water and restrooms are available.

**ENTRIES - INDIVIDUAL:** Entries in individual events will be made by using the SR-1 card, Entry and Score Reporting Card accompanied by payment. NRA members must record their NRA ID number. Circle the event in which you wish to fire. Be sure to indicate your current NRA Mid-Range or F-Class classification. Make checks payable to Eastern Nebraska Gun Club. Mail entries to Eugene Krepela 8013 Browne St. Omaha NE. 68134-2244. Individual entries must be received not later than Monday preceding the opening date of the tournament. Entries are limited to 45 competitors. Post entries will be accepted up to the stated limit of the range provided such entries will not require special relays.

The Chief Range Officer reserves the right to disqualify any unsafe rifle, ammunition, or competitor.

**TARGET OPERATION:** Competitors will be responsible for target operation and scoring. Any substitutes must be cleared with the tournament match Director. Failure to comply will result in disqualification. *Hats, eye, and ear protection are highly recommended during pit relays.*

**CHALLENGES:** A challenge fee of \$2.00 will be charged for each challenge made. See rule 16 for correct procedures.

**CLASSIFICATION:** The NRA Mid-Range and F-Class Classification system will be used in all matches. Individuals who have not been classified will fire in the master class.

**RIFLE:** Equipment allowed will be in accordance with current NRA rules. Rifles allowed are NRA *Match Rifle* Rule 3.3 or 3.3.1, 3.3.3, and NRA *Any Rifle* Rule 3.3.4 or *Service Rifle* Rules 3.1, 3.1.1, 3.1.2, 3.1.5, and 3.1.6. F-Class rifles Rule 3.4 (a) *NRA F-Class Open Rifle (F-O)* or (b) *NRA F-Class Target Rifle (F-TR)*. F-Class competitor's equipment must conform to F-Class Rules as shown on the NRA website. F-Class competitors will use the MR-1FC target centers. Compensators or muzzle brakes are prohibited (Rule 3.16.1). Empty chamber indicators are required

**SIGHTING SHOTS:** Two sighting shots will be allowed for each match. When allowed they must be taken and scored.

**TIME OF FIRING:** Firing will commence at 09:00 AM CST, each day.

### COURSE OF FIRE:

Match 1 Any Sights	One string of 20 shots for record prone with 2 sighters slow fire. 22 minutes. MR-1 600 yd target.
Match 2 Metallic Sights	One string of 20 shots for record prone with 2 sighters slow fire. 22 minutes. MR-1 600 yd target.
Match 3 Metallic Sights	One string of 20 shots for record prone with 2 sighters slow fire. 22 minutes. MR- 1 600 yd target.
Match 4	Aggregate of matches 1 through 4 for Match Winners aggregate 600.

**AWARDS:** Awards will be given for Match 4 winners based on rifle type. There must be a minimum of 4 entries per rifle type for 1st, 2nd, or 3rd place awards.
