

**Squadded Practice and CMP E.I.C. "LEG" MATCH  
EASTERN NEBRASKA GUN CLUB, July 11, 2009**

**Schedule and Match Fees: Range opens at 7:00am.**

**Saturday, July 11: 8:00 A.M. — Squadded Practice .....\$5**  
**Saturday, July 11: 12:00 P.M.\* — CMP EIC Match.....\$20(\$10 to CMP)**  
**Saturday, July 11: 12:00 P.M.\* — Director's Match (Concurrent with EIC Match).....\$10**

\*EIC Match Registration & trigger weighing begins after squadded practice. EIC Match will commence firing not earlier than 11:30am. Challenge fee--\$2.00

**Eligibility:** Match is open to the public to anyone who can legally possess a firearm (4.1) and juniors 14 years or older (4.4.3) accompanied by an adult. The Chief Range Officer reserves the right to disqualify any unsafe rifle, ammunition, or competitor.

**Saturday, July 11: Squadded Practice at 8am. (Sign-up will be at 7:00am):**

No pre-registration. No awards. No additional time. No alibis. No aggregate of the Squadded Practice. Coaching is allowed.

Match 1. Standing or Sitting, Slow Fire. No limit on rounds fired. 10 minutes at 200 yds. SR target. Rule 5.12.

Match 2. Prone position, Slow Fire. No limit on rounds fired. 5 minutes at 300 yds. SR-3 target. Rule 5.6.

Match 3. Prone position, Slow Fire. No limit on rounds fired. 5 minutes at 600 yds. MR-1 target. Rule 5.6.

**Saturday, July 11: CMP Excellence-In-Competition "Leg" Match:**

Registration and relay assignments will begin at 11:00am\*. The match will commence firing not earlier than 11:30am. *Triggers must be weighed before registration.* Pre-registration is not required.

**Course of Fire:** 50 round National Match Course fired as the CMP Service Rifle Match. No sighting shots.

**Rifles Allowed:** The M-1, M-14, or M-16 as issued by the U. S. Armed Forces (or NM) or the commercial rifle of the same type and caliber. Safe ammunition will be provided by the competitor.

**Rules:** In accordance with CMP Competition Rules, 13th Edition - 2009.

**E.I.C. Awards:** Credits towards the Distinguished Rifleman badge and Excellence-In-Competition badges will be awarded by the CMP after that office verifies scores. Official Match Results will be posted on the CMP website.

**Note: Competitors will fire the 200-yard sitting stage immediately following the 200-yard standing stage with no relay changes.**

**Saturday, July 11: Director's Match:**

A Director's Match will be fired concurrent with the EIC Match. This match is for any Service Rifle shooter who is NOT eligible for EIC points, or competitors who would like to shoot a Match Rifle. Equipment allowed will be in accordance with current NRA Match and Service Rifle rules. Compensators or muzzle brakes are prohibited. Empty chamber indicators are required. No alibis will be allowed in the Director's Match. There will be no awards.

**General Information:**

Squadding is done at the range on the day of the match, but telephone or e-mail questions are welcome. Water and restrooms are available. There will be no food or sodas provided.

**Directions to the ENGC Range:**

The range is located at marker 12700 on the north side of Highway 66, approximately 2 miles east of Louisville, NE. The High Power range is 1/2 mile north of the entrance.

*From the east:* From Hwy.75/Hwy.66 intersection at Plattsmouth, go about 12 miles west on Hwy. 66 to range. *From the west:*

From Hwy.50 at Louisville, NE, turn at the Ash Grove cement plant (Hwy.66) and proceed south across the railroad tracks, through two stop signs, and follow the curve east approximately two miles. (ENGC GPS Coor 41.011767, -96.111750).
