

**HIGH POWER RIFLE "CLUB" MATCH  
(ACROSS-THE-COURSE MATCH)  
EASTERN NEBRASKA GUN CLUB, November 14, 2009**

**Saturday, November 14: 9:00 A.M.....Match Fee: \$20.00 (Jrs. \$5.00)**

**Registration at the range.** Range will open at 7:30am. Registration will be at the trailer on the 600yd firing line between 7:30am to 8:30am. **Squadding will end at 8:30am.** Match packets will be available at the Stat. Office from 7:30am to 8:30am.

**Eligibility:** Open to the public to anyone who can legally possess a firearm, or Juniors accompanied by an adult may compete. The Chief Range Officer reserves the right to disqualify any unsafe rifle, ammunition, or competitor.

**Equipment Allowed:** Equipment allowed will be in accordance with current NRA rules. Rifles allowed are NRA *Match Rifle* Rule 3.3 or 3.3.1, or *Service Rifle* Rules 3.1, 3.1.1, 3.1.2, 3.1.3 or 3.1.6. Metallic sights-Rule 3.7a. Compensators or muzzle brakes are prohibited (Rule 3.16.1). Empty chamber indicators are required. Scoped and Any Sight Match Rifle (3.3.4) competitors are welcome, but will compete in their own group and must shoot the complete, standard course of fire, including rapid fires, as outlined. *This is not an NRA Sporting Rifle match.*

**Course of Fire: 50 shot National Match Course (7.14)**

**Note: Competitors will fire the 200-yard sitting stage immediately following the 200-yard standing stage with no relay changes.**

Match 1	2 sighters, 10 record shots, Standing, Slow Fire, 12 minutes at 200 yds. SR target. Rule 5.12.
Match 2	2 sighters, then one ten-shot rapid fire string, Sitting or Kneeling position, 60 seconds at 200 yards. SR target. Rule 5.8 or 5.10.
Match 3	2 sighters, then one ten-shot rapid fire string, Prone position, 70 seconds at 300 yards. SR-3 target. Rule 5.6.
Match 4	2 sighters, 20 record shots, Prone, Slow Fire, in 22 minutes at 600 yds. MR-1 target. Rule 5.6.
Match 5	The Aggregate of Matches 1 through 4.

© Competitors will perform scoring and pit duties on their assigned relay. Failure to do so will result in disqualification. *Hats, eye, and ear protection are highly recommended during pit relays.*

**Classifications and Awards:** NRA High Power classifications will not be used. *This is not an NRA sanctioned match and scores will not count for classifications.* Match results will be printed and given to each competitor following the match.

© Match 5 Award: High scores in the aggregate will be recognized at the end of the match. Certificates can be printed after the awards ceremony at the request of any competitor.

**General Information:** Squadding is done at the range on the day of the match, but telephone or e-mail pre-registration or questions are welcome. If you find you will be unable to attend after pre-registering, the courtesy of a phone or e-mail cancellation as soon as possible would be appreciated.

Water and restrooms are available. *There will be no food or sodas provided.* Contact Bill Keil for lodging information and directions to the range (ENGCC GPS Coor 41.011767, -96.111750).
