

**THE DENNIS SMITH HIGH POWER RIFLE MEMORIAL MATCH
NRA APPROVED (ACROSS-THE-COURSE MATCH)
EASTERN NEBRASKA GUN CLUB, October 10, 2009**

Saturday, October 10: 9:00 A.M.....Match Fee: \$25.00 (Jrs. \$5.00)(\$4.50 NRA fee is included)

Registration at the range. Range will open at 7:30am. Registration and match packets will be at the trailer on the 600yd firing line from 7:30am to 8:30am. **Squadding will end at 8:30am.**

Eligibility: Open to the public to anyone who can legally possess a firearm, and Juniors accompanied by an adult may compete. The Chief Range Officer reserves the right to disqualify any unsafe rifle, ammunition, or competitor.

Equipment Allowed: Equipment allowed will be in accordance with current NRA rules. Rifles allowed are NRA *Match Rifle* Rule 3.3 or 3.3.1, or *Service Rifle* Rules 3.1, 3.1.1, 3.1.2, 3.1.3 or 3.1.6. Metallic sights-Rule 3.7a. Rule 3.3.4 Any Sight Match Rifles will compete in a separate division. Compensators or muzzle brakes are prohibited (Rule 3.16.1). Empty chamber indicators are required. *This is not an NRA Sporting Rifle match.*

Course of Fire: 80 shot Regional Course (7.15) (1.6g)

Note: The 200-yard sitting stage may be fired immediately following the 200-yard standing stage with no relay changes.

Match 1. 2 sighters, 20 record shots, Standing, Slow Fire, in 22 minutes at 200 yards. SR target. Rule 5.12.

Match 2. 2 sighters, then two ten-shot rapid fire strings, Sitting or Kneeling position, each string in 60 seconds at 200 yards. SR target. Rule 5.8 or 5.10.

Match 3. 2 sighters, then two ten-shot rapid fire strings, Prone position, each string in 70 seconds at 300 yards. SR-3 target. Rule 5.6.

Match 4. 2 sighters, 20 record shots, Prone, Slow Fire, in 22 minutes at 600 yards. MR-1 target. Rule 5.6

Match 5. Aggregate of Matches 1 through 4.

⊙ Competitors will perform scoring and pit duties on their assigned relay. Failure to do so will result in disqualification. *Hats, eye, and ear protection are highly recommended during pit relays.*

Classifications and Awards: NRA High Power classifications will be used. Unclassified competitors, or competitors without proof of High Power classification, will compete in the Master class (Rule 19.7). Temporary Score Record Book classification may be used (Rule 19.14).

⊙ **Match 5 Awards:** High score in Match 5 will be awarded the Dennis Smith Memorial Match plaque (Any Sights excluded). The Any Sight Rifle Division high score will be awarded \$6. Class awards will be presented to the highest score in each class in Match 5. There must be a minimum of 5, 8, and 11 entries per class for 1st, 2nd, and 3rd (\$5, \$4, \$3) or the classes will be combined with the next highest class. If there are less than 5 High Masters or Any Sight entries, they will compete in their divisions for Match Winner only

⊙ **Match 1 – 4 Recognition:** High scores in each match (Match 1 – 4) will be recognized at the end of the match.

⊙ High Woman, Junior, and Senior will be recognized.

⊙ Certificate awards can be printed after the awards ceremony at the request of any competitor.

⊙ Cash award winners must be present at the end of the post-match awards ceremony to receive and sign for their money at the Statistics Office. Match results will be posted on the www.highpowerinnebraska.com.

General Information: Squadding is done at the range on the day of the match, but telephone or e-mail pre-registration or questions are welcome. If you find you will be unable to attend after pre-registering, the courtesy of a phone or e-mail cancellation as soon as possible would be appreciated.

Water and restrooms are available. *There will be no food or sodas provided.*

If the competitor is running late the day of the match – call Bill (402) 880-4868 or Aaron (402) 679-1147, otherwise late shows will be turned away (8:30am is the cut off).

Directions to the ENG C Range: The range is located at marker 12700 on the north side of Highway 66, approximately 2 miles east of Louisville, NE. The High Power range is 1/2 mile north of the entrance.

From the east: From Hwy.75/Hwy.66 intersection at Plattsmouth, go about 12 miles west on Hwy. 66 to range.

From the west: From Hwy.50 at Louisville, NE, turn at the Ash Grove cement plant (Hwy.66) and proceed south across the railroad tracks, through two stop signs, and follow the curve east approximately two miles. (ENG C GPS Coord 41.011767, -96.111750).
